Welcome and Introductions

Paul Selden briefly described Bike Friendly Kalamazoo as an informal communications network of participants and volunteers aiming to make our greater community even more bicycle friendly, for all the benefits that would bring.

The purpose of this meeting: generate ideas and priorities for efforts in 2017.

Topical Updates

MPO-wide Bike Route Network - Doug Plachcinski, Planning Administrator, Texas Twp

Next Steps: Townships will be submitting the necessary permits, and some would like volunteer help to determine and/or confirm appropriate bike route sign locations.

Highlight of Benefits

Transportation moves something from one place to another and includes bicyclists Bicyclists often cross borders of jurisdictions when they travel, so the network of bike routes needs to be cross-jurisdictional, as well.

Crashes are usually harder on bicyclists, but they impact the community as well.

A well thought out system should increase the awareness that drivers should expect to see bicyclists on properly signed routes. Bike routes are often the only option in rural areas.

The KATS Planned Commuter Bike Routes were developed over a three year period with a great deal of public involvement. As part of the KATS 2045 Transportation Plan, they were approved by the KATS Technical Committee and adopted by its Policy Committee in April 2016. So the routes are already mapped.

The Commuter Bike Route Network should help users identify the best routes to/from each major jurisdiction in the entire KATS metropolitan planning organization, encouraging new cyclists.

Bike Routes are, in general, extremely cost-efficient, with a cost for signs and their installation something around \$2,000 per mile vs. other facilities involving asphalt.

Implementing the Commuter Bike Route network will boost regional awareness in many ways, putting our region on the map and also making it easier for bicyclists to explore its attractions.

KATSMoves - Megan Arndt, Associate Planner, Kalamazoo Area Transportation Study

KATSMoves is the short name for the KATS Pedestrian, Greenway, and Transit Plan.

A primary goal of the Pedestrian, Greenway, and Transit Plan is to identify connections between new and existing non-motorized facilities and the Kalamazoo Metro Transit (KMetro) network.

KATSMoves is a 12-month planning process. Anticipated completion of the plan and a final deliverable is expected in September of 2017.

The plan is currently in the public input stage. Citizen participation is actively sought through the survey on the www.KATSMoves.org web site.

A public open house meeting is scheduled on February 7, 4-7pm at Kalamazoo Metro Transit, 530 N. Rose Street, Kalamazoo, MI 49007.

State Legislative Update - Megan Bush, District Manager, MI Sen. Margaret O'Brien Senator Margaret O'Brien plans to reintroduce the following legislation in 2017.

- House Bills 5002 and Senate Bill 1029: Would set penalties for injuring or killing a vulnerable roadway user. http://www.legislature.mi.gov/documents/2015-2016/billintroduced/House/pdf/2015-HIB-5002.pdf
- House Bill 5004 and Senate Bill 1030: Updates sentencing guidelines for those who violate HB 5002. http://www.legislature.mi.gov/documents/2015-2016/billintroduced/Senate/pdf/2016-SIB-1030.pdf
- House Bill 5003 and Senate Bill 1077 (will be running the House version.) Would require
 a five foot safe passage distance when overtaking a bicycle on the left.

- Senate Bill 1076: Would require a five foot safe passage distance when overtaking on the right side. Because passing on the right and left are included in two different statutes, this bill was required. http://www.legislature.mi.gov/documents/2015-2016/billintroduced/Senate/pdf/2016-SIB-1076.pdf
- Senate Bill 1078: Would include enhanced requirements for bicycle safety in driver education classes. There is concern that the current statute requiring education on bicycle laws does not have any "teeth," so this would set a three hour timeframe to teach about the laws pertaining to bicycles and motorcycles.

Q&A / Planning Input

Dick Skalski suggested focusing education efforts on area schools. Paul Wells wants to try to reach parents of children who learned how to ride on sidewalks at home and are getting ready to ride farther, which usually would mean needing to learn skills about riding on the roads. With more and more bicyclists on the roads, motorists and bicyclists need to develop skills accordingly. Dale Shugars asked whether there is a bicycling caucus in the Michigan legislature. Megan Bush was not aware of any. Phil Tarchala wondered whether local institutions such as banks, that have electronic signs, might be asked to use them for bike awareness messages. Patricia Randall commented that Pure Michigan might be approached to emphasize bicycling, even more. Megan Arndt emphasized that KATSMoves will mainly be looking at how to make seamless connections involving Metro Transit and other modes such as walking and biking. Dave Warwick commented that Kalamazoo Area Bike Week's new name emphasizes bicycling in the broader community, and hopes organizations will look at organizing bicycling oriented events during that week.

A more formal <u>BFK Planning Worksheet</u> was handed out at the beginning of the meeting to capture additional ideas. A copy of the survey follows on the next page, noting the results in summary form.

A <u>Commuter Bike Route Preliminary Idea Survey</u> was distributed to gather feedback about a common sign design for marking routes on the proposed Commuter Bike Route (numbered as "Map 7" in the KATS 2045 Metropolitan Transportation Plan). Note: The survey was handed out without additional orientation or discussion about "pros and cons" so as to get people's input with as little bias introduced by Paul Selden as possible. Results are on page 7, with a copy of the survey.) Seventeen surveys were returned. (Note: There were no "ties," so Paul Selden is withholding his "votes" from the tallies.) The intent was to test out the format of the survey; results are suggestive but informal. A more formal process for gathering public and representative input will commence in/after March.

- Next Steps (most likely in/after March)
 - a) incorporate as many feasible ideas as possible into general list of 2017 goals (see worksheet)
 - b) implement to extent of volunteer/participant interest and availability
 - c) further discuss (off line or at another meeting) any items where further input is needed before they can be incorporated into goal



Commuter Bike Route ("Map 7") Sign Preliminary Idea Survey Results (1-19-17)

Public discussions have been taking place about using a distinctive sign to mark the planned networks of bike routes adopted in the 2045 KATS Long Term Transportation Plan. This is a preliminary survey to explore alternative sign designs. Your input will help present the survey and concepts even more effectively. Please mark your survey per the steps below and return it at the end of our session today.

For many reasons, the sign below is the model for much of the current thinking. The distinctive "white shield on green background" is in common use and known to the public as marking routes/areas where bicyclists may be expected. There is general agreement that the term "Bikeway" has many advantages. Other general specifications (size, shape, color, etc.) will conform to Michigan standards. This particular survey is only focusing on a few remaining items.

The sign offers room for potential content in three major areas noted as Logo, Owner and Bicycle Symbol below Please review these items below and mark your survey accordingly.

- [1.4] Road agency having "jurisdiction" (a city, village, a road commission, 4. Symbol 3C may be drawn with or or MDOT logo) [8 "Votes for #1" (VF#1)]

- [3.0] Agency logo on one side, "KATS" network emblem on the other
